



MEMORANDUM OF UNDERSTANDING

between

Mariano Marcos State University, Philippines and Universitas Muhammadiyah Surabaya, Indonesia

In order to advance friendly relations between the Philippines and Indonesia, the UNIVERSITAS MUHAMMADIYAH SURABAYA (Referred to as UMSurabaya) and the MARIANO MARCOS STATE UNIVERSITY (Referred to as MMSU) join in the following agreement on the promotion of education and academic exchanges between the two parties.

Both parties will make reasonable efforts to encourage direct contact and research cooperation between their faculty members, department, and research and extension institutes, to the extent that they are able, and under provisions of this agreement, endeavor to cooperate in the fields with which parties are concerned.

Both parties agree on the following potential forms of cooperation:

- develop international programs (short courses and TNEs);
- 2. organize symposia, workshops, conferences, and meetings;
- 3. share experiences in innovative teaching methods and design of curriculum;
- 4. pursue joint research in field of mutual interests;
- 5. exchange of faculty for teaching and research assignments;
- 6. exchange of students for study and research; and
- contemplate academic internship and immersion programs.

Themes of joint activities and conditions for utilizing the results and arrangements for specific visits, exchanges, and other forms of cooperation will be negotiated for each specific case. The specific exchange arrangements and cooperation duly negotiated and determined by the parties shall be in writing and will form an integral part of this Memorandum of Understanding.

Both parties understand that all the financial arrangements shall depend on the execution of subsequent agreements and will depend upon the availability of funds.

It is understood that the implementation of this agreement will commence on the date of final signature below and that this agreement will continue thereafter for five (5) years, subject to revision or modification from time to time by mutual agreement. The possibility and the terms of a renewal of the agreement will be discussed by the representatives of both parties no less than six months prior to the natural termination of the current agreement.

Any modification, revision, or amendment of the terms agreed upon by parties can only be made in writing with the mutual consent of both parties.

Either institution may terminate the agreement at any time, although such action will only be taken after mutual consultation in order to avoid any possible inconvenience to all parties. The Termination however must be made in writing and will only take effect after six (6) months after receipt by the other party.

The parties agreed to attempt in good faith to amicably settle any conflict, controversies, or issues which may arise within or during the implementation of this collaboration.
