### MEMORANDUM OF UNDERSTANDING

### KNOW ALL MEN BY THESE PRESENTS:

This agreement entered into the Tuesday, March 10<sup>th</sup>, 2020 in Bandung, Indonesia, by and between:

The ASIA PACIFIC CONSORTIUM OF RESEARCHERS AND EDUCATORS, an international organization or researchers and educators established on December 2013, with principal office at Room 309, SCC Building, CFA Compound Sta. Mesa, Manila, Philippines, represented herein by its Executive Director, Philippines, DR. WITAWAT JANGIAM, herein referred as "APCORE";

UNIVERSITAS MUHAMMADIYAH SURABAYA, an education institution of higher learning established in 1981, with principal office at Sutorejo number 59, Surabaya, East Java, Indonesia, represented herein by its Rector, Dr. dr. Sukadiono, MM, herein referred to as the "UMSurabaya";

#### WITNESSETH THAT:

WHEREAS, in the interest of educational cooperation and in the spirit of making significant contribution to the international and intercultural education of people, the APCORE and the UMSurabaya have agreed, as they hereby agree, to form and develop a research, academic and cultural collaborative understanding;

WHEREAS, the parties acknowledge that such understanding will bring not only the professional members of their respective institutions, but also the students and the people they serve closer together in their pursuit of educational ideals;

WHEREFORE, in consideration of the above premises, the parties hereby agree as follows:

- 1. The APCORE and UMSurabaya shall assist one another to carry forward joint research collaboration and publicatation on mutually-agreed upon areas of study:
- 2. The APCORE and UMSurabaya shall enter into an agreement creating a program of exchange of their respective professional members and students for instructional, research and cultural purposes. The agreement covers all disciplines offered by the respective institutions:
- 3. The APCORE and UMSurabaya shall explore the potential of co-sponsoring international conferences, trainings, and academic exchanges in areas of joint interests, the arrangements of which shall be subjected to terms and conditions as may be mutually agreed upon by the parties;
- 4. The APCORE and UMSurabaya shall exchange educational materials, research publications and instructional information beneficial to both parties;
- 5. The APCORE and UMSurabaya shall explore the possibility of offering dual or joint-degree and non-degree programs subject to terms and conditions as may be mutually agreed by the parties.
- 6. The APCORE and UMSurabaya shall promote the membership of the Consortium and participate in the programs, projects and events organize and co-organize by the Consortium and its member institutions subject to terms and conditions as may be mutually agreed by the parties.

7. The APCORE and UMSurabaya shall facilitate exchange of experts as guest lecturers, visiting professors and resource speakers subject to terms and conditions as may be mutually agreed by the parties.

The terms and conditions specified in this mutual cooperation shall be discussed and agreed upon in writing by the appropriate responsible officers of both parties prior to the initiation of any particular program or activity.

This memorandum of agreement shall take effect upon signing thereof for a period of five (5) years. All amendments to this AGREEMENT and/or termination thereof shall be made upon mutual consent.
